1. To Declare the issuing of executive order (viz. i.e. Memo vide Memo No. 6480-P/General.A1 /2024, dated. 29/11/2024. issued by the Respondent No. 1 (Home Department), permitting exhibition of cinemas between 1.30 am to 8.30 am as contrary to Rule 12 (2) read with cinemas licensing conditions in Form-B (condition 12 (43) of the Cinemas (Regulations) Rules 1970) as arbitrary, illegal and set aside the same and consequentially prohibit the Respondent No. 1 (Home Dept.) from issuing executive orders contrary to the licensing conditions envisaged under the Cinemas Regulation Act 1955 and Cinemas Regulation Rules 1970 hereon and uphold Article 14 of the Constitution of India

2. Consequentially to direct Respondent No. 1 (Home Dept.) to consider issuing rule making minimum ninety (90) minutes duration mandatory between twos shows at any standalone theatre in Telangana so as to manage crowds and avoid stampedes occurring with 600 plus cinema goers exiting/entering a theatre

3. Consequentially to direct the Respondent No 1 (Home Dept.) to ensure the cinemas license holders under the Cinemas Regulation Act 1955, do not resort victorial publicity or use fire crackers or inflammable material, as prohibited under License Conditions outlined in Form-B, i.e. (condition 12 (14) and prohibit usage of fire crackers or inflammable material condition 12 (29) and (31), etc). and to issue necessary orders to all Cinemas Licensing Authorities in Telangana, to ensure the licensing conditions of Form-B of the Cinemas Regulation Rules 1970 are implemented scrupulously;

## IA NO: 1 OF 2024

Petition under Section 151 CPC praying that in the circumstances stated in the affidavit filed in support of the petition, the High Court may be pleased to direct Respondent No. 1 (Home Dept.) to NOT issue any orders in by whatsoever name, allowing any shows between 1.30am 8.30 am 1st in Telangana, until the final outcome of this writ petition, effectively immediately or in such other time as this Hon'ble Court may deem fit, Pending disposal of WP 37007 of 2024, on the file of the High Court.

The petition coming on for hearing, upon perusing the Petition and the affidavit filed in support thereof and upon hearing the arguments of Sri Vijay Gopal Advocate for the Petitioner and GP for Home for the respondent No.1 to 3 and Sri G. Arun Kumar, Advocate for the respondent No. 3 and Sri S. Niranjan Reddy and Sri A. Venkatesh, learned Senior counsels representing Smt Rubina S. Khatoon, Advocate for the respondent No. 4 & 5;

# The Court made the following **ORDER:**

Heard Mr. S. Niranjan Reddy and Mr. A. Venkatesh, learned senior counsel, appearing for the respondents No.4 and 5 in WP.Nos.1184 and 1189 of 2025 and WP.No.33923 of 2024 and respondents No.5 and 6 in WP.No.37007 of 2024.

Learned senior counsel submitted that the direction dated 24.01.2025, issued by this Court to the authorities restricting the entry of children below 16 years into cinema theatres, has severely impacted the business of the respondents No.4, 5 and 6, who are multiplex operators. There is no statutory restriction for allowing children of any age to watch late night movies after 11 PM. The petitioners have approached this Court aggrieved by the action of the respondent No.1 in enhancing the price of ticket of 'Pushpa-2' and 'Game Changer' movies and allowing screening of benefit shows/additional shows. Pursuant to interim order passed by this Court, the Government has taken a decision not to enhance the ticket prices and not to allow benefit shows.

Learned senior counsel further submitted that so far as the direction given by this Court to the Government to consult all the stake holders and take necessary decision for regulating entry of children below 16 years in multiplexes/theaters before 11 AM and after 11 PM is concerned, the multiplex operators are not aggrieved. It is for the administration to take a call in the interest of children and public at large. The multiplexes have been running five shows and they are permitted to run last show till 1.30 AM, as per the statutory regulations. The order of this Court restricting entry of children below 16 years is in the nature of a final order and more over, it is beyond the scope of the writ petitions, which are not public interest litigations.

Learned counsel for the petitioners submitted that there are several regulations, which would regulate the entry of children to late night shows. Though there is no specific provision as such under the regulations, on a reading of all the provisions, it would suggest that children below certain age cannot be permitted to watch late night movies.

Learned Government Pleader for Home submitted that pursuant to the order of this Court the children below 16 years are not being permitted to watch movies after 11 PM in multiplexes and theatres.

Upon hearing the learned senior counsel, this Court is of the opinion that the matter requires to be heard by giving opportunity of hearing to respondents No.4, 5 and 6 – multiplex operators, whose interest is stated to be adversely affected. It is relevant to note that there is no statutory regulation as of now restricting entry of children in theatres during late night shows. The order of this Court dated 24.01.2025 may have ramifications all over the State and may cause substantial loss to the multiplexes/theatres during release of new movies. As it is contended that the multiplex operators are stake holders and their interest have to be taken into consideration and they ought to be given opportunity before any order is passed, in the interest of justice, the order dated 24.01.2025 is modified and the direction "*Till such decision is taken the respondents shall not allow children below 16 years to watch movies after 11 PM*." shall stand deleted from the order dated 24.01.2025.

In view of the submission of the learned Government Pleader for Home that suggestions of the stake holders have been received and it is in active consideration of the Government and appropriate decision will be taken as expeditiously as possible, the respondent No.1 is directed to expedite and take a decision in terms of the order dated 24.01.2025 at the earliest.
