- 3. Pursuant to our earlier direction, the State Government has constituted a working group by Government Order dated 25 March 2025, which reads thus:-

<u>ORDER</u>

The Kerala State Legal Services Authority (KeLSA) has filed Writ petition No.8600/2025, raising concerns about the increasing brutality of ragging in educational institutions. In considering the case, the Hon'ble Court has emphasized the need for a strong legal framework and effective implementation of the Kerala Prohibition of Ragging Act, 1998 and the UGC Regulations of 2009. The Honourable High Court of Kerala, as per the order read above, has directed the State to constitute a multidisciplinary working group comprising ex-officio members and nominated experts from various fields to draft the rules and assess whether any amendments to the Kerala Prohibition of Ragging Act of 1998 are necessary.

Government have examined the matter in detail and hereby constitute multidisciplinary working group comprising the following members for the above purpose.

4. This working group should hold a preliminary meeting, in which a further plan of action can be decided. If inputs from any other fields are required, the Chairman of the working group can invite such officers / experts to attend the meeting. Chairman of the working group

will involve the representative of the Petitioner-Kerala State Legal Services Authority. The inputs sought to be given by the intervenors in writing be placed before the working group.

- 5. As per Clause 6 of the Government Order, a representative is to be nominated by the State Police Chief. Considering the gravity of the issue, the nomination should not be of an officer below the rank of Inspector General of Police.
- 6. So that the working group can hold its preliminary meeting and apprise us of the plan of action so decided, the hearing of the petition is deferred to 10 April 2025.
