IA ORDER

- [1] RULE. Learned APP waives service of notice of rule for and on behalf of the respondent State.
- [2] Present application has been preferred by the applicant accused to grant him temporary bail on account of surgery of his mother, which is likely to be performed on 26.05.2025.
- [3] Mr. Hardik Mehta, learned APP has vehemently opposed this application and submitted that date of operation has been fixed as per the convenience of the mother of the applicant. Earlier when the operation was postponed, the applicant had not immediately surrendered. Subsequently, on 18.05.2025, he has been taken by the police to the Jail authority.
- [4] Mr. I. H. Syed, learned senior counsel with Mr. Vishrut Bhandari, learned advocate for the applicant, further stated that the

operation is fixed on 26.05.2025 and on that day, operation will not be performed or it has been postponed for any other reasons, applicant will immediately surrender before the jail authority.

- [5] Considering the arguments and considering the medical papers/ certificate, the present application is partly allowed. The applicant accused shall be released on temporary bail for a period of four (04) days, starting from 26.05.2025 at 6:00 a.m. to 29.05.2025 till 9:00 p.m. with police escort consisting of one Head Constable and 2 constables at the cost of the applicant and upon furnishing a personal bond of Rs.5000/- (Rupees Five Thousand Only) with a surety of the like amount to the satisfaction of the jail authority.
- [6] It is clarified that on 26.05.2025, operation of the mother of the applicant will not be performed or postponed, the present applicant has to surrender to the jail authority immediately without fail.
- [7] The applicant shall surrender before the concerned jail authority on expiry of the temporary bail period. Rule is made absolute accordingly. Direct service is permitted.
