<u>Order</u>

06/05/2025

Per, Shree Chandrashekhar, J.

A hundred and thirty-nine writ petitions were filed by the Industrial Training Institutes (in short, "ITI") imparting vocational training to the students in different trades. They approached the writ Court to challenge the communication dated 4th September 2024 issued under the signature of the Director (Training) of the Directorate of Technical Education, Rajasthan insisting on deposit

of Rs.50,000/- per unit course in the ITIs as performance bank guarantee.

- 2. The main plank of the Training Institutes in this batch of writ petitions; vide S.B. Civil Writ Petition No.16453 of 2023 and connected matters, is the decision by this Court at Jaipur Bench delivered in S.B. Civil Writ Petition No.7378 of 2020 titled "Guru Kripa Private ITI v. State of Rajasthan & Anr." with connected writ petitions one of which was filed by "Deshraj Private ITI".
- 3. The writ petitions filed by the appellant-Training Institutes at Jodhpur Bench have, however, been dismissed by a learned Single Judge of this Court vide order dated 9th December 2024. Referring to the decision in "Guru Kripa Private ITI" and emphasizing on the observation made therein that; "this Court does not find any substance in the submission of learned counsel for the petitioner that the institute/private colleges, who were to be established after 2018, are alone required to give bank guarantee", the learned Single Judge held that the Training Institutes running the vocational courses are liable to comply with the condition of furnishing bank guarantee whether such Training Institutes were established prior to 2018 or afterwards.
- 4. In the order dated 9th December 2024 passed in the present case, the learned Single Judge bestowed his considerations to the issues raised by the Training Institutes and held as under:
 - "12. The undisputed facts disclosed in the present writ petition and other connected matters are that the petitioners are private ITI colleges established at different period of time prior to 2018. The institutions are running and rendering technical education to the students in the State of Rajasthan. The State Government has issued the directions to all those private institutions for deposition of

Bank Guarantee of Rs.50,000/- per unit, keeping in mind the fact that if an institution is closed in mid session, the students admitted by that particular institution are required to be adjusted in some other institute including Government institute to safeguard the future of those students and in the process, the expenditure is incurred. In order to prevent such a situation, the order of deposition of Bank Guarantee of Rs.50,000/- per unit has been passed by the State Government. In the opinion of this Court, the intention of the State Government appears to be just, proper and pious.

13. The argument of the learned counsel for the petitioners that the order passed in the case of Guru Kripa Pvt. ITI (supra) is only to the extent that the private institutions which are established after 2018, are required to deposit Bank Guarantee of Rs.50,000/- per unit and not the institutions which are established prior to 2018. A bare perusal of the order rendered by the coordinate Bench in the case of Guru Kripa Pvt. ITI (supra)clearly goes to show that the argument of the learned counsel for the petitioners is untenable and incorrect. The co-ordinate Bench has held as under:-

"This Court does not not find any substance in the submission of learned counsel for the petitioners that the institutes/private colleges, who were to be established after 2018, were alone required to give bank guarantee.

This Court finds that all colleges either they were already running or if new colleges were to be set up, the requirement of bank guarantee, was to be complied with by all such institutes."

The above finding clearly goes to show that the distinction which the learned counsel for the petitioners is trying to make has already been rejected by the co-ordinate Bench.

- 14. The said order dated 02.12.2020 has been affirmed by the Hon'ble Division Bench of this Court at Jaipur Bench vide judgment dated 18.07.2023 in the case of the Deshraj Pvt. ITI & Ors. (supra). 15. This Court is firmly of the view that the order/notice dated 04.09.2024 asking for deposition of the Bank Guarantee of Rs.50,000/- per unit is perfectly justified to secure the future of the students who are undertaking technical education in these private institutions.
- 16. This Court is of the opinion that imposition of such condition with a pious object will only enhance the confidence of the students as well as the institutions, who are genuinely involved in imparting technical education. Such condition shall also operate as a deterrent to the bogus entrepreneurs and will only encourage the genuine

entrepreneurs to establish the private ITI institutions in the State of Rajasthan.

- 17. In the order passed by the co-ordinate Bench of this Court at Jaipur Bench, there is no stipulation that the condition of deposition of Bank Guarantee of Rs.50,000/- per unit is applicable only on those institutions who have been established after 2018 and, therefore, even the institutions which are established prior to 2018 are under an obligation to deposit Bank Guarantee of Rs.50,000/- per unit as ordered by the respondents vide order/notice dated 04.09.2024 and other orders issued from time to time.
- 18. In view of the discussions made above, no interference is warranted in these writ petitions and the same are devoid of any force. Hence, the present writ petitions are dismissed."
- 5. Aggrieved thereby, the Training Institutes have preferred these Special Appeals. The short point raised by Mr. M.A. Siddique, the learned counsel appearing for the appellant-Training Institutes is whether the learned Single Judge misconstrued the decision in "Guru Kripa Private ITI" in so far as the said decision deals with the Training Institutes established prior to 2018.
- 6. The Apprentices Act, 1961 was enacted in the wake of the Government policies providing substantial impetus to the industrial growth which required large number of trained manpower. It was in that background that a need was felt that the training to the apprentices should be regulated by a legislation. Under sub-section 2(I) of the Apprentices Act, the establishment of National Council for Training in Vocational Trades was envisaged by a resolution of the Government of India in the Ministry of Labour (Directorate General of Resettlement and Employment); this was renamed as National Council for Vocational Training. The establishment of the State Councils for Training in Vocational Trades by the State Governments was envisaged under section

- 2(o). Section 11 lays down the obligations of the employers in relation to an apprentice. It provides that the employer shall (a) provide apprentice the training in his trade in accordance with the provisions of the Act and the Rules made thereunder (b) if the employer is not himself qualified in the trade then ensure that a person who possesses the prescribed qualifications is placed in charge of the training of the apprentice (bb) provide adequate instructional staff possessing such qualifications as may be prescribed for imparting practical and theoretical training and facilities for trade test of apprentices, and (c) carry out its obligations under the contract of apprenticeship. Under the provisions of the Apprentices Act and the Rules framed thereunder, the Sub-committee of NCVT exercises the powers to issue directions to the establishments, industrial establishments and private Institutes imparting vocational courses.
- 7. The appellant-Training Institutes were established prior to Academic Year-2018. These Institutes were affiliation/recognition in different years by the competent authority and are running vocational courses in different trades. These Institutes are governed under the Apprentices Rules, 1992 which were framed in exercise of the powers conferred by sub-section (1) of section 37 of the Apprentices Act, 1961. In the past, there was an attempt by the State of Rajasthan to frame additional norms for performance bank guarantee of Rs.50,000/- per unit for the affiliated Training Institutes from NCVT as a mandatory condition. This issue was discussed in the meeting of the Subcommittee of NCVT held on 31st July 2014. The minutes of the said



meeting was circulated to the members of the Sub-committee of NCVT vide communication dated 11th August 2014. The item no.3 of the agenda before the Sub-committee of NCVT was with respect to the additional norms framed by the State Government(s). The said agenda was deliberated upon by the Sub-committee of NCVT and a decision was taken to ask the State Government(s) not to frame any additional norms without prior permission of the NCVT for the trades/units affiliated with NCVT. A decision was also taken to advice the State of Rajasthan to discontinue the practice of seeking deposit of Rs.50,000/- per unit as performance bank guarantee.

Later on, the Directorate General of Training issued a 8. communication dated 25th April 2018 to all the State directors/UT's regarding the security deposit. It is recorded in the communication dated 25th April 2018 that the Sub-committee of NCVT took a decision in its meeting held on 27th March 2018 that the previous letter issued by the Directorate General of Training advising the State Government(s) not to compel the ITI's to deposit any security money should be recalled. As indicated in communication dated 25th April 2018, the reason for roll back of the previous letter issued by the Directorate General of Training was taken in the light of the fact that the day to day administration of ITI's is administered by the respective State Directorates. This is the case set up by the respondent-State of Rajasthan that the communication dated 4th September 2024 was issued to the Training Institutes running the vocational courses to furnish security deposit of Rs.50,000/- per unit through bank guarantee, pursuant to the said letter dated 25th April 2018.



9. The order dated 4th September 2024 passed by the Director, Department of Skill, Employment and Entrepreneurship reads as thus:

10. In the counter affidavit of the respondents, several objections to maintainability of the writ petition were taken. The respondents set up a stand that the writ petitions involved serious disputed questions of fact and, that, no cause of action had arisen for the private Training Institutes to approach the writ Court. The respondents further pleaded that incorrect facts were stated by the writ petitioners and the decision in "Guru Kripa Private ITI" was mis-interpreted to put-forth the plea that the Training Institutes established prior to Academic Year-2018 were not required to furnish bank guarantee. According to the respondents, the exemption granted to the Training Institutes was only to the extent of Academic Years-2014 to 2018. Stressing on the need for requiring security deposit from the Training Institutes running different vocational courses, the respondents pleaded thus:

"....the petitioners have made incorrect facts regarding the decision, The petitioners are making incorrect interpretation of the decision rendered in writ petition no. 7378/2020. The Hon'ble Court in writ petition no. 7378/2020 decided on 02.12.2020 has held that the

private ITI institution have to pay bank guarantee from Acadmic Session 2018 onwards and it was no where held that institution established prior to session 2018 are exempted from the payment of bank guarantee. Session. The only exemption is for session 2014 to 2018 as payment of bank guarantee so the private ITI institution running training continuously have to pay bank guarantee 2018 onwards hence the writ petition is liable to be dismissed due to conduct of the petitioners.

- 4. With due respect, it is further respectfully submitted that receiving bank guarantee from the institution is the policy decision of the government and Hon'ble Court generally refrain to interfere in the policy decision of the State government and the controversy is no more res integra as the Hon'ble Court has already affirmed the policy decision of State Government to receive bank guarantee. Hence, the present writ petition is bereft of merit and liable to be dismissed.
- 5. With due respect, it is further respectfully submitted that the bank guarantee was sought from the private ITI institutions for smooth functioning of the collages. The basic purpose of receiving bank guarantee is that if on account of any Irregularity if the occasion arose to close the institution in mid of session then the expenses of remaining training of student will be borne by state government from the fund generated from bank guarantee and the bank guarantee is sought after conscious decision of NCVT Sub Committee meeting held on 27.03.2018 and further on basis of letter dated 25.04.2018 issued by the Government of India, so seeking of bank guarantee from the Pvt. ITI is as per law and no interference is warranted in the present matter. Hence, the present writ petition is devoid of merit and liable to be dismissed.
- 6. That upon bare perusal of the meno of Writ Petition filed by the Petitioners would clear show that the Petitioners have concealed and suppressed so many important facts from the consideration of this Hon'ble High Court and in the respectful submission of the Answering Respondents, the same cannot be resolved in the summary proceedings under Article 226/227 of the constitution of India and being so, the present Writ Petition is not maintainable and the same deserves to be dismissed by this Hon'ble High Court on this count also in view of the well settled propositions of law laid down by this Hon'ble High Court as well as Hon'ble Supreme Court of India in this respect.
- 7. That the present writ petition is liable to be rejected on the count of disputed question of facts. In the present writ petition it is

contained several disputed question of facts which cannot be adjudicated in the present writ petition. Moreover, particularly these type of disputed question of facts can only be adjudicated by the Civil Courts, for the Forum of this Hon'ble High Court it is not appropriate for the petitioners.

- 8. That the present writ petition is not maintainable in eye of law being the reason That for the writ of mandamus a prior notice or intimation has to be given but in the present case there is no such type of document on record which establish the fact that prerequisite condition has been complied with by the petitioners before filing the present writ of mandamus....
- 11. That it is most respectfully submitted that for impartation of efficient and smooth training decision was taken to ask for bank guarantee of Rs. 50,000/- from the private ITT's running in the State of Rajasthan vide circular dated 03.01.2006. That the objective of taking bank guarantee from the private ITI's is that primarily it is the responsibility of the private ITI's to successfully and efficiently complete the training of the students admitted in the institute. However, in any situation institute is closed in the middle of the session than it is the duty of the answering respondent to complete the session and expenses of rest of the training will be completed by using the money deposited in the form of bank guarantee. Therefore, bank guarantee to the tune of Rs. 50,000/per unit was asked from the new ITI's and for opening of new units in old ITI's. That after deposition of the bank guarantee private institutes completes courses with responsibility. That though the DGT New Delhi vide order dated 11.08.2014 ordered not to ask for bank guarantee however, the DGT, New Delhi vide order dated 25.04.2018 called back its earlier order dated 11.08.2014 and gave permission for taking bank guarantee from the private institutes. A copy of the circular dated 03.01.2006 is attached herewith for your ready reference and marked as Annexure R/3."
- 11. Complaining breach of natural justice and challenging the jurisdiction of the State Government to frame additional norms for the Training Institutes, several writ petitions were filed in the High Court at Jaipur Bench. Those writ petitions were disposed of by a common judgment delivered in "Guru Kripa Pvt. Iti & Ors. v State of Rajasthan & Anr." (S.B. Civil Writ Petition No.7378 of 2020) and



connected matters. The writ Court held that the Training Institutes established or running from Academic Year-2018 are required to furnish security deposit and disposed of all the petitions with the following directions:

- "...Accordingly, all these writ petitions are disposed of with the following directions:-
- (i) That the colleges which were covered during the period for the Session 2014 to 2017, could not have been compelled to give bank guarantee.
- (ii) That the private ITIs colleges which were established or which were already running from the Session 2018 onwards, are required to give bank guarantee as desired by Government of India and implemented by the Government of Rajasthan.
- (iii) The interim orders passed by this Court in respect of petitioner-Colleges established or running prior to 2018 will govern their cases & no insistence will be made to pay bank guarantee and all those Colleges which have got interim orders for the Session 2018 onwards, will have to deposit the bank guarantee as desired by the respondents..."
- 12. The decision in "Guru Kripa Private ITI" was unsuccessfully challenged by the Training Institutes which were running the vocational courses since Academic Year-2018 onwards. In "Deshraj Pvt. Iti & Ors. v State of Rajasthan & Ors." (D.B. Special Appeal Writ No.147 of 2021), the Division Bench of this Court at Jaipur Bench passed the following order:
 - "....6. Therefore, in light of the stipulations stated hereinabove, especially qua the issuance of letter dated 25.04.2018 by the Government of India, which were duly taken into consideration by the learned Single Judge while passing the impugned order dated 02.12.2020, we deem it fit to hold that the State Government exercised discretion well within its powers as well as jurisdiction to require the furnishing of bank performance guarantees from the Academic Session 2018 onward.



- 7. Accordingly, in light of the above, the argument(s) raised by the appellants qua the lack of jurisdiction on part of the State Government to issue the impugned order imposing the requirement to furnish the performance bank guarantee behest of any rule or provision, is not tenable.
- 8. Thus, in the opinion of this Court, the learned Single Judge has passed a well-reasoned speaking order and after consideration of material aspects, arrived at a logical conclusion. Therefore, no interference with the impugned order dated 02.12.2020 is warranted...."
- Pertinently, "Deshraj Private ITI" and other Institutes which approached the Division Bench of this Court at Jaipur Bench were established or granted recognition from Academic Year-2018. Therefore, whether or not the Training Institutes established or granted affiliation/recognition prior to Academic Year-2018 are liable to furnish security deposit was not an issue in "Deshraj Private ITI" and batch cases. This is also a matter of record that the direction no. (i) in "Guru Kripa Private ITI" and connected matters was not challenged by the State Government. Notwithstanding some observations by the writ Court in "Guru Kripa Private ITI" and connected matters, the decision of the writ Court is that "the colleges which were covered during the period for the session 2014-2017 could not have been compelled to give bank guarantee". There is another reason to support the decision in "Guru kripa Private ITI". The duration of different courses of vocational training conducted by the Training Institutes which are affiliated to the National Council for Vocational Training ranges between 1-2 years and the apprentices who were admitted in a 2-year course in Academic Year-2017 would complete the

course in the year 2019. Whereas, the decision in "Guru Kripa Private ITI" clearly says under the direction no.(iii) that the Training Institutes established or running prior to 2018 are not required to furnish security deposit. In "Kanai Lal Sur v. Paramnidhi Sadhukhan" (1957) SCC OnLine SC 8, the Hon'ble Supreme Court observed that when the material words are capable of two constructions, one of which is likely to defeat or impair the policy of the statute or notification whilst the other construction is likely to assist in achieving that policy, then the Court should prefer to adopt the latter construction. The direction nos.(i) and (iii) in "Guru Kripa Private ITI" are clear and unambiguous. Therefore, having regard to such indisputed facts, we have formed an opinion that the Training Institutes established/recognized prior to the year 2018 are not covered under the impugned communication dated 4th September 2018.

- 14. Mr. Mansoor Ahmed Siddqui, the learned counsel appearing for the appellant-Training Institutes contends that the decision in "Guru Kripa Private ITI" which has attained finality was binding on the writ Court and the direction nos. (i) and (iii) in the said case which relate to the Training Institutes established/recognized prior to Academic Year-2018 should have been followed and applied by the learned Single Judge to give similar benefits to the appellant-Training Institutes.
- 15. The persons who are likely to be affected by the decisions of the Court shall have a natural and reasonable expectation that the previous decisions of the Court rendered in identical facts shall be adhered to. The binding nature of a decision of the Court is an

issue that also pertains to judicial discipline and propriety and requires that the decision of a co-ordinate Bench is followed by the other Courts of co-equal strength and are not lightly disregarded. Indicating that in the decisions of the Supreme Court it has been reiterated time and again that judicial indiscipline is invaluable and inviolable rule to be followed by the Judges, the Hon'ble Supreme Court held in "Mary Pushpam v. Telvi Curusumary & Ors." 2024 INSC 8A that a Bench of co-equal strength must respect a decision of the co-ordinate Bench of the same High Court and that decision shall have binding effect subject to the latter Bench of co-equal quorum taking a different view and referring a question in law to a larger Bench. In "Krishena Kumar & Anr. v. Union of India" (1990) 4 SCC 207, the Hon'ble Supreme Court held that a principle of law laid down by the Court should be adhered to and applied to all future cases where facts are substantially the same. We may also refer to "Hari Singh v. State of Haryana" (1993) 3 SCC 114 wherein the Hon'ble Supreme Court observed that in a judicial system the Courts of co-ordinate jurisdiction must have consistent opinions on identical set of facts or on a question of law. In our opinion, the learned Single Judge was swayed away by some observation in the body of the judgment in "Guru Kripa Private ITI" and overlooked the clear finding recorded under direction no.(iii) therein.

16. In view thereof, the order dated 9th December 2024 passed in S.B. Civil Writ Petition No.16408 of 2024 and connected matters



is set aside qua the present appellants. The Special Appeals in this batch are, accordingly, allowed.
