UPON hearing the counsel the Court made the following
O R D E R

1. These matters pertain to the elections of District Bar

Associations of Karnal and Rohtak. There have been, however,

complaints with respect to the fairness and transparency in

conducting elections in various District Bar Associations in the

State of Punjab and Haryana.

2. As of now, it is difficult to say whether there is any prima

facie merit in the allegations and counter allegations. However, in

order to ensure that the Bar Council, as a statutory body, remains

above Board, we have suggested on the previous date of hearing that

they may nominate a former Judge of the High Court, especially if

anyone who is well-conversant with the functioning of the Bar

Association/Bar Council, to act as the Election Tribunal, to

conduct State wide elections. We are still awaiting the response

from the State Bar Council.

3. We direct the Chairman of the Bar Council to submit a proposal

in this regard within five days.

4. Post the matters on 27.05.2025.
