UPON hearing the counsel the Court made the following O R D E R

I.A. No.1045/2025

- 1. Learned counsel for the ICICI Bank states that the Bank will not pursue the recovery proceedings and no coercive action, of any nature, against the home-buyers will be taken till the matter is resolved by this Court.
- 2. Taking note of the statement made by learned counsel, I.A. stands disposed of.

I.A. No. 81203/2025

- 1. The Indiabulls Housing Finance Ltd. (now Sammaan Capital Ltd.) is said to have continued with the recovery proceedings and is taking coercive action by sending the anti-social elements to the applicant's house, despite a categorical order passed by this Court regarding staying of such recovery proceedings.
- 2. It is directed that no action for recovery of the house loan shall be taken against the applicant.
- 3. The Managing Director of the Indiabulls Housing Finance Ltd. (now Sammaan Capital Ltd.) is directed to remain present in the Court on the next date of hearing to show-cause as to why contempt of court proceedings, under the Contempt of Courts Act, 1971, be not initiated against him.
