## <u>O R D E R</u>

Accused Nos.1 and 2 in S.C.(PMLA) No.2 of 2025 on the files of the Special Court (SPE/CBI)-1, Ernakulam, who are the petitioners herein assail Annexure.III order dated 07.03.2025, whereby the learned Special Judge issued summons to the accused, without complying Section 223(1) of the BNSS.

2. The learned counsel for the petitioners placed decision of the Apex Court reported in [2025 KHC OnLine 6565 (SC)] Kushal Kumar Agarwal v. Directorate of Enforcement, wherein the Apex Court held that, Section 223(1) puts an embargo on the power of the Court to take cognizance by providing that no cognizance of an offence shall be taken by the Magistrate without giving the accused an opportunity of being heard, and failure to comply with this mandatory requirement renders the cognizance order liable to be set aside.

3. Thus, an arguable point is made out to be decided in this case.

4. The learned Standing Counsel for Central Bureau of

Investigation seeks adjournment to next week.

Post on 03.07.2025 to address the question. In the meanwhile, since the accused/petitioners received summons, their appearance before the Special Court stands deferred till 03.07.2025.
