

## HON'BLE DR. JUSTICE PUSHPENDRA SINGH BHATI HON'BLE MR. JUSTICE BIPIN GUPTA

#### Order

1. Issue notice.





- 2. Mr. Narendra Singh Rajpurohit, learned AAG puts in appearance for respondent no. 1. Learned counsel Mr. Sangram Choudhary puts in appearance for behalf of respondent no. 2. Mr. Shreyansh Mardia appears for respondent no. 4. Thus, notices be issued to respondent no. 3 only.
- 3. Learned counsel for the appellant submits that the counseling needs to be stopped in order to avoid creeping in of any kind of discrepancies at this stage without finalizing the NOCs.
- 4. Learned Additional Advocate General submits that his instructions are also to allow counseling only after the NOCs have been addressed. The joint proposition of the State and RUHS seems to be reasonable.
- 5. The counseling for the B.Sc. Nursing Course for the academic year 2025-26 shall remain stayed until further orders.
- 6. Once the NOCs are dealt with, any party may file an application for the continuation of counseling, which shall be duly considered at that time.
- 7. This order is passed based on submissions made by the counsel for RUHS and the State Additional Advocate General.
- 8. Ordinarily, this Court would hesitate to stay the entire counseling process, considering the larger public interest. However, in this case, to prevent deviations in the Nursing Courses for the academic year 2025-26 and to avoid the creation of conflicting rights, this order is passed with a direction to the State to expeditiously address the NOCs, preferably within two weeks.
- 9. In the meantime, counsel for the appellant shall be required to remove the defects.





10. List the matter after two weeks.
