ORDER

1. Heard learned counsel for the parties.
2. The present transfer petition has been filed by the petitioner-wife seeking transfer of the marriage petition initiated at the instance of the respondent-husband bearing D.M.C. No.241 of 2022, titled as "*Anil Kumar Sharma Vs. Shashi*", pending in the Court of Principal Judge, Family Court, Sonipat (Haryana) to the Court of Principal Judge, Family Court, Karkardooma Court, Shahdara, Delhi.
3. During the pendency of the present petition, the parties were referred to the Supreme Court Mediation Centre for exploring the possibility of an amicable settlement.
4. The Settlement Agreement has been arrived between the parties on 14.02.2025. The said Settlement Agreement is on record. Under the said settlement,

the respondent-husband has agreed to transfer the property bearing No.Second Floor, House No.1/4603, Gali No.2-A, Ram Nagar Extension, Mandoli Road, Shahdara, Delhi-110032 in favour of the petitioner-wife, which has already been transferred on 25.07.2025. The respondent-husband has also agreed to pay maintenance @ Rs.10,000/- per month to the petitioner-wife and the parties have also agreed to get the marriage dissolved by mutual consent, in respect whereof, first motion of the parties has already been arrived on 28.04.2025 before the Family Court.

5. In view of the aforesaid facts and circumstances, as the Family Court is seized with the matter, regarding passing of the decree of divorce between the parties, learned counsel for the petitioner submits that the transfer petition may be dismissed as withdrawn.

6. The transfer petition is, accordingly, dismissed as withdrawn.
