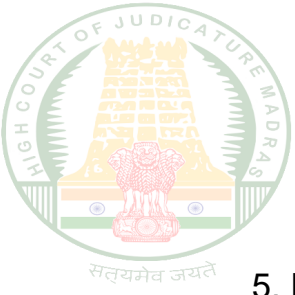
ORDER

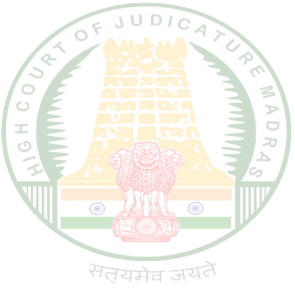
